Navigating ICANN information and resources

ICANN's mission is to help ensure a stable, secure, and unified global Internet. To reach another person on the Internet, you need to type an address – a name or a number – into your computer or other device. That address must be unique so computers know where to find each other. ICANN helps coordinate and support these unique identifiers across the world.

ICANN was formed in 1998 as a nonprofit, public-benefit corporation with a community of participants from all over the world. The multistakeholder model of Internet governance has played a crucial role in shaping an inclusive, sustainable, and effective governance structure for the Internet. By leveraging the strengths and perspectives of different stakeholders, it promotes a balanced and consensus-driven approach to managing the Internet as it becomes an increasingly critical global resource.

As a Supported Applicant, you are now a stakeholder and may have questions about how ICANN operates, why you may want to get involved, and where to find more information. [ICANN for Beginners](#) is a great place to start.

Understanding your ASP benefits

The New gTLD Program: 2026 Round is intended to expand the Domain Name System via gTLDs that reflect new communities, geographies, and voices; and to provide new domain name registries with opportunities to innovate and compete, giving consumers more choice.

Applying for a gTLD requires significant financial and technical resources and may be out of reach for some. The intent of the ASP is to make the New gTLD Program: 2026 Round application and evaluation processes and fees more accessible to entities that would like to operate a registry but are unable to apply because of financial and other resource constraints.

As a Supported Applicant, you have access to the benefits and services that can assist you throughout the process – from applying for a gTLD, through contracting and delegation, into maintaining a sustainable registry.

Accessing the right support at the right time

Various support mechanisms are available depending on your individual needs or questions. Supported Applicants are encouraged to access all resources available to ensure you have the awareness, knowledge, and ability to complete the required steps to submit a gTLD application when the round opens.

Applicant Counselor

The Applicant Counselor provides guidance to supported applicants through regular touch-points, publications, and communications. Some areas where you may have questions include:

- **Where to find existing published materials and resources** on topics such as: Domain Name System (DNS), gTLD case studies on sustainable business models, ICANN Grant program, Community Priority Evaluation (CPE) bid credits, Extended Evaluations, Objections, Contention Sets, and more.

- **How to access RSP resources** for finding service providers and how to connect with them.
 - **Understanding costs involved** with the gTLD application process.
 - **Understanding contracting requirements**, such as: Registry Customer Support, reservation and use of names, participation in Registry Stakeholder Group, etc.

Mentors

Mentors volunteer their time to provide perspective and guidance based on their own personal experience in the industry. A mentor may provide advice on:

- **The Domain Name Industry** - the different types of business models to consider and other aspects of running a registry.
- **ICANN** - how to engage with ICANN's multi-stakeholder community and which committees may be beneficial for you to join.
- **The gTLD application** - navigating the application and evaluation processes, identifying resources, providing guidance, and sharing experience as appropriate.

Pro Bono Service Providers

Pro Bono Service Providers offer volunteer hours for professional services related to their technical, legal, translation, and general business areas of expertise. A pro bono provider could help with various aspects of your gTLD application including:

- **General business services** to provide assistance in developing business and marketing plans, guidance in operationalizing a gTLD, translation services, financial, and/or legal services.
- **Application services** for guidance in writing and submitting a comprehensive, complete, and competitive gTLD application.
- **Technical services** to help navigate the technical aspects of a gTLD application and understand the ongoing infrastructure requirements to run a registry including: RSP services, Internationalized Domain Names, DNS services, proxy services, rights protection management, and more.

The ALAC is the primary organizational home for the voice and concerns of the individual Internet user, representing the At-Large Community. Advocating for the interests of end-users, the ALAC advises on the activities of ICANN, including Internet policies developed by ICANN's Supporting Organizations; it also participates in ICANN's outreach and engagement programs. Individual ALAC members are organized into five Regional At-Large Organizations (RALOs) based on their geographic regions including Africa (AFRALO), Asia, Australasia and Pacific Islands (APRALO), Europe (EURALO), Latin America and the Caribbean islands (LACRALO), and North America (NARALO).

The GNSO develops (and over time, recommends changes to) policies for gTLDs (e.g., .com, .org, .biz). The GNSO strives to keep gTLDs operating in a fair, orderly fashion across one global Internet, while promoting innovation and competition. The GNSO is structured around four broad stakeholder groups in order to represent the wide variety of groups and individuals that compose the ICANN community. There are multiple ways to participate in the GNSO – both as an applicant and when you become a Registry Operator.

The Business Constituency is a body representing the views of the Internet business user community. The BC represents business of all types – multi-nationals, medium-size, and small enterprises. One of the BC's strengths is its association membership – which extends outreach directly to over 50,000 companies and indirectly to over 1.5 million companies worldwide.

Building knowledge through multiple resource offerings, news, and events

Learning content aims to provide applicants with comprehensive and easy-to-use resources presented in various formats to support different learner types. Learning resources incorporate an on-demand learning curriculum, virtual touch-points, newsletters, and information on upcoming meetings and events that may be of interest.

Applicant Readiness Pathway A self-service learning pathway will guide you from onboarding as a newly supported applicant, to preparing to apply for a gTLD, to submitting a gTLD application, navigating the evaluation process, and other application services. These materials are designed to meet you where you are in your knowledge and understanding of ICANN, the DNS ecosystem, and the gTLD application process. New resources and materials will be added as the program progresses for just-in-time capacity development to guide your journey.

Meetings and Webinars Regular virtual touch-points throughout the learning journey have been designed to help you stay informed and educated on key topics of interest. ICANN intends to partner with the community to collaborate on live and recorded webinars educating on aspects of the gTLD application process and applicant journey, and highlighting business and industry expertise. Notifications will be sent when new events are offered.

Community Connections Guidance on becoming part of the complex ICANN community and Internet ecosystem will be offered in different formats - through webinars, ICANN meetings, learning curricula, and online resources. Engagement in the ICANN community is critical for success as a registry operator and getting involved early is an important part of the learning journey.

Newsletter Supported applicants will have a dedicated newsletter containing reminders, new developments, additional resources, and tips for navigating the applicant journey. The newsletter is also a forum for providing feedback on how things are going, what resources are useful, and where ICANN can make improvements to support you.

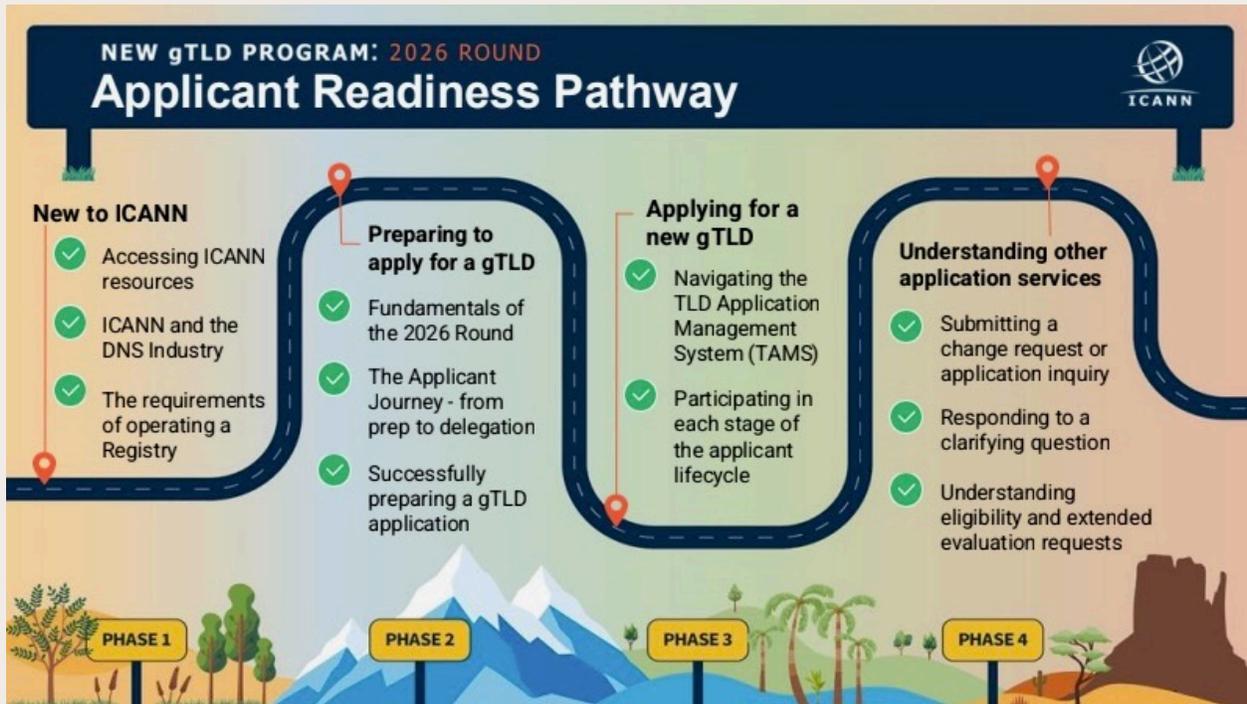
1. **Identify, locate, and navigate New gTLD Program** information, Applicant Guidebook, and other resources.

Navigating the Applicant Readiness Pathway

Supported Applicants may start with varying levels of knowledge. The learning curriculum encompasses four phases - it begins with ensuring a baseline understanding of ICANN, the DNS ecosystem, and the requirements of operating a Registry, as well as in-depth knowledge of the new gTLD Program: 2026 Round applicant journey, specific evaluations, and the ability to use the TLD Application Management System (TAMS).

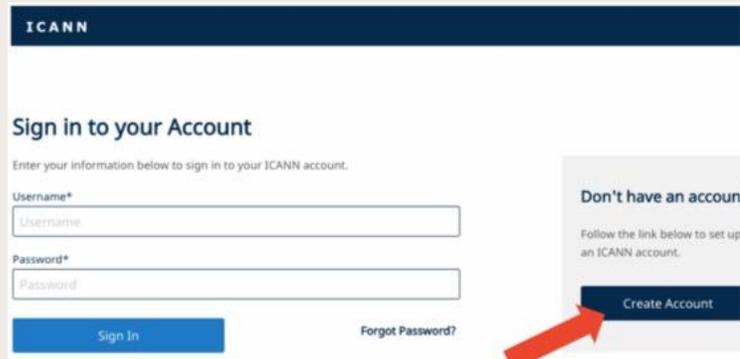

Logging into your ICANN Account

[ICANN Learn](#) is a useful platform to begin to build your foundational knowledge. Follow the instructions below to access ICANN Learn, see the Phase 1 learning curriculum assigned to all ASP Supported Applicants, and start your learning journey today.

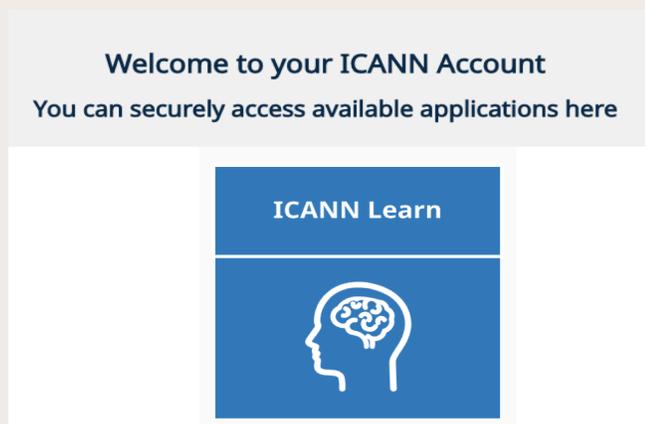
1. If you are new to ICANN and ICANN Learn, first visit learn.icann.org and create an ICANN Account, as shown with the red arrow. Then, fill out the required information and click **“Create Account”**.

If you have registered with an ICANN Account before, just type in your username and password in the fields to the left and click **“Sign In.”**



2. If you already had an ICANN Account and signed in, it will take you directly to ICANN Learn – please go on to step three.

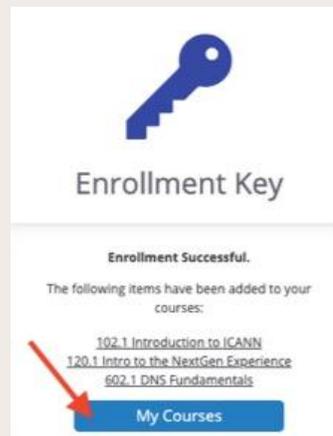
If you had to create a new ICANN Account, you will be taken to your ICANN applications. From there, you can click on the ICANN Learn tile.



- Once you've launched ICANN Learn and are in the ICANN Learn dashboard, scroll down and click on **"Enrollment Key,"** as shown with the red arrow below.



- Enter the key:
 phase 1: **ASP2025P1**
 phase 2: coming soon
 phase 3: coming soon
 phase 4: coming soon
- The key will automatically enroll you in the ASP Supported Applicant Phase 1 courses. You can find the courses by clicking on "My Courses," as shown with the red arrow below.



Learning courses and other learning opportunities are continually being developed and will be added to the learning pathway as they become available. You will receive updates when more courses are assigned, with new enrollment keys for each phase in the ASP Supported Applicant Learning Pathway.
